**PUBLIC INVITATION TO TENDER**

**For award of public contract for the supply of goods and related services – equipment and installations of plant for artificial snow production for requirements of „Stara Planina“ Ski Center, services of delivery and installation of equipment and artificial snow production plants and services of development of accompanying design and technical documentation for artificial snow production plant,

Public Enterprise „Skijališta Srsbije“, Nemanjina 22-26, Beograd, invites all interested domestic and foreign legal and natural persons to submit their written tender in compliance with conditions from the public invitation and tender dossier.

Subject of this public invitation to tender is public procurement of equipment and installations of the plant for artificial snow production, and rendering of related services of delivery and installation of equipment and installation of artificial snowing plant as well as service of development of design and technical documentation.

More detailed specification of the subject of public procurement may be found in tender dossier, and it consists of:

- 1) Equipment and installations of artificial snow production plant;
- 2) Delivery and installation of the equipment;
- 3) Development of accompanying design & technical documentation (development of preliminary design, main design and section of the main design in the form of Bill of Quantities for construction works).

Participation in public procurement procedure is open to all interested legal and natural persons meeting necessary conditions prescribed by provisions of Art.45 and Art.46 of the Public Procurement Law, Planning and Construction Law as well as other conditions defined by tender dossier.

The Tenderer should prove its eligibility producing supporting documentation together with its Tender.

Insight into tender dossier is possible upon expiry of 8 (eight) days from the date of publication of this public invitation in “Official Gazette of RS” and up to the 25<sup>th</sup> day from the date of publication of this public invitation in “Official Gazette of RS”, each working day 9-13 office hours, in the premises of Public Enterprise “Skijališta Srbije”, Narodnih heroja 43, Beograd, 17th floor (up to 31.03.2008) and in the premises of Public Enterprise “Skijališta Srbije” (from 01.04.2008.); i.e. taking over of the same

may be done upon expiry of 8 days from the date of publication of this public invitation in "Official Gazette of RS" and up to the 25<sup>th</sup> day from the date of publication of this public invitation in "Official Gazette of RS", at the above mentioned address, against authorization for taking over and presentation of evidence on non-refundable payment in the amount of 1,000.00 EUR, counter-value in RSD at an average exchange rate of the National Bank of Serbia valid on the date of payment, to gyro account No: 205-124079-40 opened with Komercijalna Banka A.D., payment for: "Public Procurement of equipment and installations of artificial snow production plant, Stara Planina No. 10/08".

Tenders should be submitted within 30 days from the date of public invitation announcement in the "Official Gazette of the Republic of Serbia" and not later than until 13:00h on the last date of tender submission deadline. In case the last day for submission of tenders is not a working day, the first following day will be considered as the last day for tender submission.

The tender which does not reach the Employer by indicated day and hour will be considered unduly received, and such tender will be returned to the Tenderer unopened, upon completion of the procedure of tender opening session.

Tenders should be marked: "Tender for public procurement of equipment and installations of artificial snow production plant, Stara Planina No. 10/08 – Do not open", with clearly indicated name of the Tenderer and address on reverse.

Validity of tender should be at least 60 days from the date of tender opening.

Tenders will be opened in public.

Public tender opening session will take place immediately upon expiry of tender submission deadline, i.e. the last day of tender submission deadline at 13:30 h in the premises of JP "Skijališta Srbije", Bulevar umetnosti 16, 1.st floor, 11070 Belgrade.

Tender opening session may be attended by authorized representatives of Tenderers, who will present their written authorizations for participation in the tender opening procedure, sealed and signed by authorized person to the Evaluation Committee, before the start of tender opening session.

Criterion for selection of the most favorable tender is economically most favorable offer, pursuant to Art.55 of the Public Procurement Law.

Decision on contract award will be made within 15 days from the date of public tender opening and all Tenderers will be informed accordingly, in writing.
