PUBLIC INVITATION

For awarding contract on public purchasing of goods, works and accompanying services – detachable four-seater ski lift of capacity 2,400 skiers per hour, with construction, electro-mounting and mechanical works and delivery of design documentation with validation according to “turn-key” system, on the mountain Kopaonik – Gobelja, Republic of Serbia

The Ministry of Economy and Regional Development, Belgrade, invites all interested home and foreign legal and physical entities to submit their written offer in accordance with conditions of public invitation and bidding documents.

The subject of the public invitation is a public purchasing of detachable four-seater ski lift of capacity 2,400 skiers per hour, with construction, electro-mounting and mechanical works and delivery of design documentation with validation according to "turn-key" system, at the mountain Kopaonik – Gobelja, Republic of Serbia.

Detailed specification of the subject of the public purchasing is in the bidding documents, consisting of the following:

1. Delivery of detachable four-seater ski lift of capacity 2,400 skiers per hour.
Delivery service of elements, parts and materials for detachable four-seater ski lift, at parity CIP Kopaonik – Gobelja.
2. Performance of construction, electro-mounting and mechanical works on construction and mounting of detachable four-seater ski lift.
3. Delivery of design of the referred ski lift, as well as validation of the main design.

All interested legal and physical entities that fulfill compulsory conditions according to the Article 45 and the Article 46 of the Law on Public Purchasing, the Law on Planning and Construction and other conditions as defined by bidding documents have the right to participate in the process of public purchasing. The bidder is obliged to submit evidence on fulfillment of conditions with his offer.

Inspection of bidding documents may be performed within 25 days from the day of announcement of the public invitation in the "Official Gazette of RS", on working days from 9 a.m. to 3 p.m. in the premises of PE "Ski Resorts of Serbia", Bulevar umetnosti, number 16a, 1st floor, Belgrade, i.e. taking over of the same may be performed after 25th day from announcement of the public invitation in the "Official Gazette of RS" at the above mentioned address, with authorization for taking over bidding documents and presenting evidence on payment of counter-value of 1,000 € in dinars according to the average exchange rate of the National Bank of Serbia at the day of payment, effected to account number 205-124079-40 with Komercijalna banka ad, purpose of payment "Public purchasing of detachable four-seater ski lift at the mountain Kopaonik – Gobelja, number of purchasing 270/08".

The term for submitting offers is 30 days from the date of announcement in "Official Gazette of RS" until 1 p.m., i.e. until the day and time stated in bidding documents, to the address:

Offers may be submitted in person or by mail.

Offers must be marked "Offer for public purchasing of detachable four-seater ski lift at the mountain Kopaonik – Gobelja, number 270/08 – DO NOT OPEN", and at the backside must have the name of the bidder and address.

In case that the last day of the term is not working day, the first working day after that will be the last day for submitting offers.

Offer of the bidder that does not reach the Orderer until the referred day and time will be considered undue and such an offer will be returned to the bidder unopened after termination of the procedure of opening offers.

Offer must be valid at least 60 days from the date of opening offers.

Opening of offers is public.

Public opening of offers will be performed immediately after termination of the term for submitting offers, i.e. on the last day of the term at 1:30 p.m. in the premises of the Ministry of Economy and Regional Development, Department for Tourism, 11070 New Belgrade, Bulevar Omladinskih brigada, number 1, room 207, 2nd floor, SIV III.

Authorized representatives of bidders may be present at opening of offers, who will present their written authorizations for participating in the procedure of opening offers, verified by seal and signature of authorized person, to the Committee for public purchasing before starting of the procedure of opening offers.

Criterion for selecting the best offer is economically most favorable offer, in accordance with the Article 55 of the Law on Public Purchasing.

Decision on awarding contract will be made at least within 10 days from the date of opening offers, and all bidders will be informed in written form.
