**For awarding contract on public purchasing of system for artificial snowing
for needs of the ski resort “Stara planina”,
according to “turn-key” system

Public Enterprise “Ski Resorts of Serbia”, Bulevar umetnosti 16a, New Belgrade invites all interested domestic and foreign legal and physical entities to submit their written offers in accordance with the conditions from the public invitation and the bidding documents.

Subject of the public invitation is public purchasing of a system for artificial snowing for the needs of the ski resort “Stara planina” according to “turn-key” system.

Detailed specification of the subject of public purchasing is within the bidding documents, and the subject of public purchasing consists of the following:

- 1) Making of Preliminary and Main design, in accordance with the Law on Planning and Construction;
- 2) Delivery of equipment for the system for artificial snowing;
- 3) Carrying out of construction, electro-mounting and mechanical works on building and assembling the system for artificial snowing.

All interested domestic and foreign legal and physical entities that fulfill compulsory conditions according to the Article 45 and Article 46 of the Law on Public Purchasing, the Law on Planning and Construction and other conditions defined by the Bidding documents have the right to participate in the procedure. Bidder is obliged to submit with his offer evidence on fulfillment of these conditions.

Inspection and take over of the bidding documents is possible within 30 days from the date of announcing the public invitation in the “Official Gazette of RS” on working days from 9 a.m. to 3 p.m. in the premises of the PE “Ski Resorts of Serbia” at the address Bulevar umetnosti 16a, 1st floor, New Belgrade, with authorization for taking over the bidding documents and presentation of the evidence on payment of 1,000.00 €

Local bidders shall pay the amount of EUR 1.000,00 in countervalue in dinars as per the mean exchange rate of the National bank of Serbia at the day of payment, at the account of Public enterprise „Ski resorts of Serbia“ number 205-124079-40 with Komercijalna banka a.d., purpose of payment „Public purchasing of system for artificial snowing – Stara planina, number of purchasing 40/08“.

Foreign bidders shall pay the amount of EUR 1.000,00 to the account of Public enterprise „Ski resorts of Serbia“ according to the payment instructions: Intermediary: DRESDEFF, Dresdner bank AG, Frankfurt am Main, Germany, Beneficiary's Bank: KOBBRSBGXXX, Komercijalna banka a.d., Belgrade, Republic of Srbija, Beneficiary: RS35205002018339000020, JP „Skijališta Srbije“, Bulevar umetnosti 16a, Belgrade, Republic of Serbia, with reference: „Public purchasing of system for artificial snowing – Stara planina, number of purchasing 40/08“.

Paid amount is non-refundable and any bank charges and fees shall be paid by the bidders.

The term for submitting offers is 40 days from announcing the public invitation in the “Official Gazette of RS” until 1 p.m., i.e. until the date and time and in the manner as stated in the Bidding documents. Offers are submitted to the address:

In case that the last day of the term is not a working day, then the first next working day will be considered the last day of the term.

An offer from a bidder that has not reached the Orderer until the referred day and hour will be considered as late and such an offer will be returned to the bidder unopened after finishing of the procedure of opening offers.

Offers may be submitted in person or by registered mail.

Offers must be marked “Offer for public purchasing of system for artificial snowing at the Stara planina, number of purchasing 40/08 – do not open”, and on the backside of the envelope, there must be the name and address of the bidder.

The offer must be valid at least 60 days from the day of opening the offers.

Opening of offers is public.

Public opening of offers will be performed immediately after termination of the term for submitting offers, i.e. on the last day of the term at 1:30 p.m. in the premises of the PE “Ski Resorts of Serbia” at the address Bulevar umetnosti 16a, 1st floor, New Belgrade.

Authorized representatives of the bidders may be present at opening of offers, who will submit their written authorizations, verified with seal and signature of the authorized person, for participating in the procedure of opening of offers to the Committee for public purchasing before the beginning of opening offers.

The criterion for selection of the most favorable offer is the most favorable offer economically, in accordance with the Article 55 of the Law on Public Purchasing.

Decision on awarding the contract will be made approximately within 15 days from the day of opening the offers. All the bidders will be informed in written form on the decision.
